

# SOUTHERN TEACHERS & PARENTS FEDERAL CREDIT UNION ELECTION NOTICE - APRIL 2021

The Southern Teachers & Parents Federal Credit Union (ST&PFCU) is pleased to announce that the annual meeting will be held virtually on Tuesday July 27, 2021 at 6:00 P.M.

The election will be for four (4) Board of Directors positions. There will be no nominations from the floor. Nominations will come from the Nominating Committee or by Petition.

Members must be at least 18 years of age to be eligible to vote, be members in good standing, and only the member whose name appears first on the regular share account is entitled to vote.

## **NOMINATING COMMITTEE**

## **CRITERIA FOR CANDIDATES**

3. Candidates must be bondable by our bonding agency Credit Union National Association.

**NOMINATIONS BY PETITION**

Nominations may be made by petition signed by at least 1% of the membership which on March 31, **2021**, was 4,388 members, 1% being 44 members. Members signing petitions must be eighteen (18) years of age or older, and every signature must be verifiable using the information specified on the Nominating Petition. Nominating Petitions may be picked up at our office at 728 Harding Blvd., Baton Rouge, LA, or from our office at 1271 St. Charles St., Thibodaux, LA. To be effective, such nomination must be accompanied by a certification from the nominee that he/she is agreeable to the nomination and will serve if elected to office. A statement of qualifications including biographical data, of not more than (60) words and signed by the candidate should accompany the petition and certification statement. These documents must be received in the credit union office or branch, to the attention of the board Secretary, by the close of business 4:30 p.m., **June 17th**. All nominees must meet the Criteria for Candidates.
